Methodology and Background

The current Iraqi internal displacement crisis originated with conflict in Anbar governorate between Armed Groups (AGs) and the Iraq Security Forces in late 2013, rapidly spreading to Ninewa and other central governorates of Iraq in June 2014. Four major waves of mass displacement have occurred alongside multiple smaller cases since 2014, including recent displacement resulting from the Mosul offensive that started in October 2016.¹ As of February 2017, 3,030,006 internally displaced persons (IDPs) have been identified across Iraq.² Of these, 746,475 individuals are registered as living in 77 formal camps nation-wide.³ To monitor these camps comprehensively and inform a more effective humanitarian response, the CCCM Cluster and REACH Initiative (REACH) conduct Quarterly IDP Camp Profiling rounds that aim to provide regular and updated information on developments, needs, and gaps in all accessible IDP camps across Iraq. The CCCM cluster and REACH have previously conducted six rounds of IDP Camp Profiling and mapping – in October 2014, January 2015, September/October 2015, December 2015, April 2016 and August-September 2016.

Round VII of the Quarterly IDP Camp Profiling was conducted in December 2016-January 2017, during which 56 formally recognized IDP camps across Iraq were assessed. The remaining camps that were not assessed were not accessible to field teams at the time of assessment, due to security concerns and/or lack of authorisation. The coverage of this Quarterly IDP Camp Profiling round has expanded further than in the previous round into new camps in Anbar, Kirkuk, Salah al-Din as well as Mosul Emergency Camps in Ninewa governorate. A mixed-methods research methodology was used which incorporates household-level sampling in each assessed IDP camp, Key Informant Interviews (KIIs) with each camp manager, satellite imagery analysis, and participatory mapping. Data collection took place from 21 December 2016 to 26 January 2017. All household-level sampling was conducted with a 95% level of confidence and 10% margin of error at the camp level, while analysis at the governorate-level was weighted according to the population sizes of camps. In total, 5,389 households were assessed.

Limitations

- Findings for Ninewa governorate include four new Mosul Emergency Camps: Hasansham U3, Khazer M1, Khazer M2 and Qaymawa. As these camps were built rapidly in response to the IDP influx from the Mosul Offensive, services and infrastructure are generally of a lower standard than pre-existing camps. As such these camps act as outliers. Ninewa governorate findings therefore may vary when compared to the previous assessments in April 2016 and August-September 2016.
- GPS tracking of camp infrastructure in the Centre-South was not possible due to authorisation issues. Area calculations in some camps subsequently could not be determined
- The overall confidence level of 95% applies to those findings which pertain to the full sample. Any findings
 presented solely on subsets of the population e.g. barriers to non-attendance in school inevitably have
 a lower confidence level. In particular those findings which relate to a very small subset of the population
 should be treated as indicative only.
- Governorate comparisons are weighted by camp population sizes. Some governorates only have one camp; as such outliers are more pronounced and should be taken into account when comparing governorates.




IDP Camp Locations and Sample Size




EXECUTIVE SUMMARY

Demographics

Across Iraq, households were displaced from their area of origin since May 2015 on average. Most households in Baghdad, Dahuk, Diyala, Kerbala, Missan, Najaf and Sulaymaniyah displaced between August-October 2014. In contrast, the average date of displacement in Anbar, Erbil and Ninewa was August-November 2015 while in Kirkuk and Salah al-Din it was January-February 2016. The demographic breakdown of the population has remained comparable to previous rounds with 51% of the IDP camp population under the age of 18, and 4% over the age of 60. The majority of respondents originated from Ninewa (59%) followed by Anbar (24%) and Kirkuk (6%).

Shelter and Non-Food Items

Tents remain the predominant shelter type in IDP camps in Iraq, although variation was found at the governorate level. Overall, 81% of households were observed to reside in tents followed by caravans (15%). Tents were more prominent in Kirkuk (100%), Salah al-Din (100%), Ninewa (95%) and Sulaymaniyah while caravans were more commonly observed in Kerbala (100%), Missan (100%), Najaf (100%) and Baghdad (75%). Of the households observed to be residing in tents, only 47% across Iraq had cement bases, highlighting different levels of service provision in relation to shelter infrastructure (cement bases provide additional protection against flooding). Variation was found at the governorate level: particularly low observations of cement bases were reported in Anbar (3%) and Erbil (12%), especially in comparison to other governorates which ranged between 88% in Sulaymaniyah and 98% in Kirkuk. Across Iraq, 37% of households reported kerosene heaters among the top needed basic household items, followed by kerosene (30%).

Food Security

The majority of households (92%) reported access to food assistance in the three months prior to the assessment, with lower proportions reported in Kirkuk (88%), Anbar (84%) and Salah al-Din (66%). Across the country, the average reported access to the Public Distribution System (PDS) was 69%. Particularly low proportions of access to PDS were reported in Salah al-Din (51%), Erbil (49%) and Diyala (45). IDP households continued to report using negative food coping strategies – 45% across Iraq, indicating that many are struggling to meet all their basic food needs. Of those who reported one, the most commonly reported coping strategy was the consumption of cheaper food of lesser quality (44%).

Livelihoods

The majority of IDP households in camps continue to engage in negative livelihood-based coping strategies in order to meet their basic needs. Across Iraq, 70% of households reported using negative coping strategies, representing a slight increase of 8% since August-September 2016. The most reported livelihood coping strategies were the accumulation of debt (32%), spending savings (20%) and selling assets (14%).

An increase in debt accumulation was more prominent in northern governorates, especially in Diyala and Sulaymaniyah – potentially due to more prolonged displacement. In Diyala, 26% of households reported debt accumulation as a coping strategy, representing a 12 percentage point increase from August-September figures. Similarly, households in Sulaymaniyah reported that debt accumulation increased from 25% in August-September to 44% in December 2016-January 2017. In Ninewa governorate, overall household reporting on debt accumulation decreased from 44% to 31%, however these results have been impacted by the inclusion of Mosul Emergency Camps in this round. Likely due to their recent arrival, in Hasansham U3, Khazer M1 and Hasansham M2, the proportion of

households reporting the use of debt was significantly lower than other camps in the governorate: 11%, 8% and 6% respectively, compared to a range of 30% in Bardarash camp and 66% in Essian. Households in Hasansham M2, Hasansham U3 and Khazer M1 were more likely to sell assistance - 44%, 28% and 26% respectively, followed by relying on family and friends for support - 24 % in Hasansham U3 and in Hasansham M2 and 22% in Khazer M1.

Protection

Protection concerns remain widespread, particularly in relation to missing documentation, access to Child Friendly Spaces (CFS) and receiving adequate information about registration/documentation, available assistance and legal rights. Across Iraq, 19% of households reported missing documentation, with particularly high proportions found in Baghdad and Salah Al-Din - 33% and 25% respectively. Access to CFS in Southern Governorates remains low: none in Najaf, 5% in Salah al-Din, and 20% in Missan, compared to 70% in Erbil, 71% in Ninewa and 81% in Sulaymaniyah. Across Iraq, the majority of households reported receiving adequate information about registration/documentation (87%), available assistance (80%) and legal rights (71%). However, variation was found at the governorate level especially in Ninewa and Salah al-Din. In Ninewa camps, only 55% of households in Hasansham U3, 46% in Khazer M1 and 45% in Hasansham M2 reported receiving adequate information about registration/ documentation. This is significantly lower than in other camps in the governorate where figures ranged from 78% in Garmawa to 95% in Qaymawa.

WASH

Service gaps in water and sanitation were widespread throughout IDP camps in Iraq: 15% of all households reported going without access to water for at least one 24-hour period in the past month, with the highest rates seen in Kerbala (60%), Salah al-Din (42%), Ninewa (29%), Kirkuk (27%) and Erbil (26%). At the camp level, very high rates of households without access to water for at least one day last month were reported in Al Hardania camp (Salah-Al Din), Khazer M1 (Ninewa) and Kerbala MODM (Kerbala) – 100%, 71% and 60%, respectively. Waste disposal was most commonly through collection (72%) or communal bins (24%). However, throwing waste in the street was reported by 9% in Anbar and 27% in Salah al-Din while burning

waste was reported by 98% of households in Najaf RHU and 9% in Baghdad.

Health

There was a noticeable increase in households reporting a lack of access to a consistent supply of essential medicine for pregnant, lactating, chronically ill, and/or disabled members – 42% this round compared to 21% in August/September 2016. Camps in the South reported the lowest rates of access – 7% in Najaf, 16% in Salah al-Din and 23% in Anbar compared to 91% in Dahuk and Erbil and 92% in Sulaymaniyah. The reported proportion of children under five who are vaccinated against polio has also decreased this round – 64% compared to 78% in August-September. Once again, lowest figures were reported in the southern governorates of Anbar (34%), Kerbala (54%) and Salah al-Din (58%).

Education

The number of children reported to attend formal education has decreased slightly and remains particularly low in Southern governorates. Overall 59% of children aged 6-11 are attending school, representing an 8 percentage point decrease since August-September. In Anbar and Salah al-Din lower figures were reported – 30% and 23%, respectively. Older children, especially girls are less likely to attend formal education: 48% of boys and 41% of girls aged 12-17 reportedly attend formal education across Iraq. Key barriers to school attendance were the child being disinterested (27%) and no school being available (15%).

Camp Coordination and Camp Management

Similar to the April and August-September 2016 rounds of camp profiling, 95% of IDPs reported being aware of IDP Committees in the camp. Despite the relatively high reported existence of committees in the camps, findings indicate that committees are perceived not to be elected by the camp residents: only 14% of households across the Iraq reported perceiving that committees were elected by camp population, while 30% reported not knowing. Across Iraq, 24% of households reported making a complaint in the previous three months about their conditions, assistance or other issues. Of these households, only 32% reported that they perceived an action was taken, while 63% perceived nothing happened as the result of their complaint.



Summary






IDP Camp Map - Bajed Kandala









IDP Camp Map - Qaymawa










